PROJECT OBJECTIVES

- A. To conduct a region-wide school climate assessment of K-12 schools in 22 school districts across Southern Illinois.
- B. To assess the effectiveness of training school administrators, teachers and staff in the delivery of low-cost, evidenced-based interventions addressing key components identified in critical reviews of bullying prevention programs.
- C. To assess the impact of facilitating anonymous reporting of school safety issues via a web-based platform on school climate.

Design/Analyses: random assignment of schools to intervention years; hierarchical linear modeling for nested structures based on mixed effects longitudinal models for repeated outcomes.

METHOD

- Data collection for this presentation occurred March May 2016
- Surveys were collected from 40 ROE#30 elementary, middle and high schools
- Measure: School Climate Survey (Ontario Ministry of Education), separate versions:
 - Grades 4 to 6
 - Grades 7 to 12
- Procedure: Surveys completed anonymously in classes at times/days designated by administrators.

SCHOOLS

- Schools were located in Jackson, Perry, Union, Pulaski and Alexander Counties.
- Each is in one of the following four classifications as defined by the National Center for Education Statistics (NCES):
 - 33 Town, Remote
 - 41 Rural, Fringe
 - 42 Rural, Distant
 - 43 Rural, Remote
- The majority of districts are classified as 42-Rural, Distant.



PRELIMINARY FINDINGS

SCHOOL SAMPLES

- Grades 4 to 6
 - Total N = 2463
 - Schools = 30
- Grades 7 to 12
 - Total N = 3046
 - Schools = 24




Actions meant to hurt another person's feelings or to put a person down are called **bullying/harassing** behaviors. Bullying is a form of harassment.

In this section, we will be using the words "bullying/harassment" for behaviors such as:


- saying hurtful things to someone about their appearance, their intelligence, or their abilities;
- posting hurtful comments about someone online;
- hurting someone by hitting, kicking, or pinching them, or in some other physical way;
- leaving someone out or treating them badly because of who they are.

The same person or group of people is often bullied or harassed over and over again. This can happen on or off school grounds.


FREQUENCY OF PHYSICAL BULLYING GRADES 4-6




FREQUENCY OF VERBAL BULLYING GRADES 4-6

FREQUENCY OF ELECTRONIC BULLYING BY GRADES 4-6






CLIMATE SCALE SCORES GRADES 4 TO 6 BY SCHOOL

Perceptions of Climate




SAFETY SCALE SCORES GRADES 4 TO 6 BY SCHOOL

Perceptions of Safety




BULLIED SCALE SCORES GRADES 4 TO 6 BY SCHOOL

Experienced Bullying




WITNESS SCALE SCORES GRADES 4 TO 6 BY SCHOOL

Witnessed Bullying




BULLY SCALE SCORES GRADES 4 TO 6 BY SCHOOL




FREQUENCY OF REPORTING GRADES 4 TO 6




FREQUENCY OF PHYSICAL BULLYING GRADES 7 TO 12




FREQUENCY OF VERBAL BULLYING GRADES 7-12






SAFETY SCALES GRADES 7-12 BY SCHOOL




BULLIED SCALE SCORES GRADES 7-12 BY SCHOOL

Experienced Bullying




WITNESS SCALE SCORES GRADES 7-12 BY SCHOOL

Witnessed Bullying




BULLY SCALE SCORES GRADES 7-12 BY SCHOOL

- NCSSLE Workshop Training August 2016/2017
- Wave 1 Systematic Supervision Training (Dec Mar 2017)
- Coding of School Disciplinary/Bullying Policies (2015-2016, 2016-2017)
- Year 2 data entry & analysis *in progress*
- Anonymous web-based reporting launch in progress
- Wave 2 Systematic Training *in progress*

ISSUES THAT HAVE ARISEN

- Issues in randomization
- Difficulties in scheduling survey collection
- Parents opting students out of participation in some districts
- Teacher objections to survey content for fourth sixth graders
- Modifications teachers made to NCCSLE workshop curriculum
- Administrator concerns regarding liability for information received through web portal
- Changes in LEA staff members
- Changes in Illinois Legislation related to bullying
